Department of Education, H.P. has no objection to permit the management of DAV. Public School, Chumana in Distt. Palspur, H.P. to seek affiliation to CBSE, New Delhi (upto 10th Standard)

The grant of this permission shall, however, not entitle the school to any grant-in-aid from this Department of the Govt. of H.P.

This N.O.C. is issued subject to the following conditions.

1. No pupil shall be refused admission on account of his caste creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste creed or religion.
2. No pupil shall be compelled to attend a class in which a religious instruction is given or take part in any religious excercises.
3. The school with its account books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Department, Executive Officers of the Govt. authorised to inspect schools and Health Officer deputed by the Health Department to examine the health of the student, or sanitary condition of the building and premises.
4. The schools shall have to furnish all information and returns as called for by the Department from time to time.
5. The school shall comply with the rules of the Department and directions as given by the department so far as they are applicable to private schools in the interest of maintaining education standaed. The Director of Education shall have the authority to send any of his officer for inspection for proper maintenance of educational standaed, holiday as per State Govt. etc.
6. The school staff and students shall not take part in any agitation directed against the authority of Govt. or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt. or of enmity and hatred between different communities.
7. The school shall charge the rates of tution fee and subscription to boys funds in accordance with the scales prescribed or approved by the Education Department of H.P./ CBSE/ICSE and schools shall have to submit a classwise list of tution fee and funds to this Directorate.

- 8. The schools shall maintain the discipline properly.
- 9. The school shall take steps to promote the use of Hindi. The extent of reservation for SC & ST students at the time of admission be adhered to.
- 10. The school shall have to work within the framework of National priorities.
- 11. In the matter of appointments of teaching/non-teaching staff preference will be given to the Himachalis.
- 12. Free education will be imparted to the Girls students.

The breach of any of the conditions specified above shall render the school defaulter and the Director of Education after conducting any enquiry through any of the officers so designed by him, shall have the power to cancel the N.O.C.

Subject:- Grant of permission to run/establish of a private educational institution.

Sir/Madam,

On the careful consideration of the inspection report submitted by the Inspection Committee District Bilaspur vide letter No.-EDN-BLS(A)(5)2/2021-13415-16 dated: 28-06-2021 constituted for the purpose of inspection of Private Educational Institutions of the School level for grant of permission to run/establish a private educational institution by the Govt. of H.P. Shimla vide Notification No.-Shiksha-II-Chha(11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha 5P-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "**Dayanand Anglo-Vedic Collage Trust & Management Society, New Delhi**" registered under as per the provision of Registration Act, 1860 (Registration No.-S-9 of 1948-1949) dated 30-06-1948 for the establishment of "**D.A.V. Sr. Sec. School Ghumarwin, P.O. & Tehsil Ghumarwin, District Bilaspur H.P.-174021**" for 9th to 12th (only Science Stream for 10+1 & 10+2 classes) classes from the academic session 2022-23 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

1. That the school concerned shall be affiliated to **Central Board of Secondary Education Shiksha Kendra-2, Community Centre, Preet Vihar, Vikas Marg, Delhi-110301 for 9th to 10+2 (Science Stream only) classes.**
2. That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
3. That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
4. That the private institution shall employ only the trained/eligible staff as per the norms fixed by the State Govt. before the start of academic session 2021-22.
5. That no particular religious education shall be impacted by the institution to maintain secular character of the institution.
6. That the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students. (Donation in any form from the student is strictly prohibited).
7. That the permission to run or establish a private educational institution shall be granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
8. That the institution shall maintain proper record accounts and register in accordance with norms of HP Govt. As stated in chapter III of the Himachal Pradesh Private Educational

Institutions (Regulation) Act, 1997 and Notification No. Shiksha-II-(Ga) 6-1/98 dated 10-06-2008 Corrigendum of the same.

9. *That the institutions shall have to comply with the norms/provisions of the H.P. Private Educational Institutions (Regulation) Act, 1997 and rules notified by the Govt. vide notification No. Shiksha-II-(Ga)6-1/989 dated 19-10-2004 corrigendum dated 10-06-2008 and the instructions issued by the competent authority from time to time.*
10. *That the school shall have to furnish all information and returns as called for by the Department from time to time.*
11. *That the society will make efforts to acquire its own land and establish the institution in its own land.*
12. *That the recruitment of staff will be made after following proper procedure i.e. by advertisement at least in two leading national daily newspaper and getting sponsorship of names from the nearest employment exchange giving full detail of the qualifications required and scales of pay plus allowances payable by the school.*
13. *That the salary of staff is to be paid strictly through RTGS/on line system only.*
14. *It should be mentioned noticeably/highlighted in the prospectus of the institution, details of the staff & their qualifications, fees, funds and other relevant information about the institutions and information regarding grant of permission of the Govt. To establish and run the institution.*
15. *That the name of the affiliating Board of the institution should be mentioned in the prospectus with Approval No. Registration No. And Affiliation No. the same should also be displayed on the notice boards of the institutions, at least 2-3 places visible easily to all.*
16. *That the Society will provide the facility of provident fund as per the EPF norms to its staff and will take up welfare programme for the employees and students as well.*
17. *That the Manager shall, within six months after the end of the every Academic year, submit to the competent authority the report of Chartered Accountant on the Audit of the Accounts under sub-section (1).*
18. ***That the concerned school will also not charge fee towards Building fund, Infrastructure fund and development fund etc. from the students/parents.***
19. *The Principal/ Headmaster /Management of the Private School will ensure that there are no Biddies/ Cigarettes, Gutkha and other Tobacco Products shops and liquor shops within the 100 meters radius of the Schools / Institution as per Section (6) of the COTPA Act 2003.*
20. *The Principal/ Headmaster /Management/ SMC of the Private School will ensure that FIR is registered against the person under Section 77 of Juvenile Justice Act, 2017 in case found selling of intoxicating liquor or any narcotic drug or tobacco products or psychotropic substance to any child near to Schools/ Educational Institutions.*
21. *The Principal/ Headmaster /Management of the Private School will ensure to get the police verification of all the staff members working in the school, mandatorily.*

The breach of any of the conditions specified above shall render the "Dayanand Anglo-Vedic Collage Trust & Management Society, New Delhi" defaulter and the action for the withdrawal/cancellation of the permission so granted shall be initiated.
